## **BORDER CROSSING**

We recommend you either apply for a temporary work visa for the convention dates OR you tell customs that you are attending a tattoo convention, you are bringing your machines and power supplies to potentially trade and/or to attend seminars and learn how to tattoo better at the convention.

We can NOT guarantee you entry and we are NOT responsible if you are denied, arrested, deported etc.

There are NO refunds if you can not attend due to the border denying you entry.

Contact an Immigration Lawyer to discuss your best options:

#### Items you can NOT cross the border with:

- · Fruits and vegetables
- Plants and cut flowers
- Meat and animal products
- Live animals \*must declare & have correct paperwork and permits
- Firewood.
- Most types weapons such as tasers, brass knuckles, and pepper spray.
- Guns
- Certain knives, even those used for hunting or fishing.
- Radar detectors
- Obscene material, hate propaganda and child pornography. They can inspect your laptops, cellphones and other computer equipment to see what you have on them.
- All camping gear, recreational equipment and supplies must be clean and free of pests and soil.

#### Restricted Items Requiring some sort of license or permit

- You must declare all firearms and weapons when you enter Canada. If not, they will be seized and you will likely be fined and could face criminal charges. A personal firearm that is OK in Texas is not allowed into Canada. You need documents to prove that you are entitled to possess a firearm in Canada and you must transport it safely. It is our understanding that if you declare a weapon before a search is made there won't be any charges and that the weapon will be returned to you when you leave the country. Permits are also required for explosives, fireworks and certain types of ammunition. You should review our page on <a href="Importing a Firearm or Weapon Into Canada">Importing a Firearm or Weapon Into Canada</a> for more information.
- Regulations on food and meat products change constantly. Many will be confiscated at the border. You can check the Canadian Food Inspection Agency <u>Automated Import</u> <u>Reference System</u> for more information or call the CBIS.
- A permit is required for some types of live bait.
- If you have an American operator's license, you may use your aircraft, marine or amateur radio while visiting Canada without a Canadian license. All other types of radio transmitting stations may only be used if registered with Canada.

#### Bringing Jewelry and other Valuables across the border

Don't bring them. Other than the obvious risk of loss, it is often difficult to validate that you brought jewelry or other valuables with you as opposed to purchasing them on your trip. If you must bring them, see our page on pre-trip registration procedures.

#### **General Recommendations:**

- If you are going to be carrying large amounts of consumable products, such as food or fuel, you should contact the Customs office before you begin your trip to determine what special measures you should take. This will help you avoid duties for importation.
- Do not wrap gifts before crossing the border. You may be required to unwrap the gifts so a border agent can inspect it.
- If you have used items that look like they might have been purchased on your trip you could be asked to pay duties on them. You can avoid this by registering them before you leave the country or by bringing proof-of-purchase documents such as sales receipts, insurance policies or jeweler's appraisals.
- Do not bring more than a pack or two of cigarettes or other tobacco products. If they
  spot more than that the question of importing will come up and you may be asked
  additional questions.
- Special Note: Customs Officials know that vehicle imports are one of the most commonly undervalued goods and they take a hard-line when the purchase price is misrepresented. This can result in penalties as high as 55% of the amount that was not declared, forfeiture of the vehicle, and criminal prosecution.
- If you have prescription drugs make sure they are well labeled. It is best to carry the original bottle they came in rather than transferring them to generic travel containers. See our page on <a href="What to Declare">What to Declare</a> for more information.

#### **Documents Needed to Enter Canada**

To cross the border into Canada you will need the following documents:

- American Citizens: A passport is not required but is strongly recommended.
   Alternatively, you will need other documentation that shows proof of American citizenship such as a birth certificate, a certificate of citizenship or naturalization or a Certificate of Indian Status, plus a photo ID. Remember, you will need to comply with the stricter U.S. entry requirements to return to the U.S.
- For Canadians returning to Canada: a passport is strongly recommended by the Canadian Border Services Agency. Otherwise, you will need proof of citizenship and a photo identification card. Other forms of identification can include Enhanced Driver's License (EDL)/Enhanced Identification Card (EIC), NEXUS card, Free and Secure Trade (FAST) card, Canadian citizenship card, Certificate of Indian Status, or a Birth certificate in combination with either a driver's licence or a government-issued photo identification. The CBSA warns that these other forms of documentation may cause significant delay and trigger secondary screening as border officers try to verify your information.

#### **Duties on Americans Entering Canada**

U.S. citizens crossing the border into Canada to visit are allowed to bring the following item quantities into Canada duty free:

- 1.5 liters of wine, or 1.14 liters (40 ounces) of liquor, or 24 cans or bottles of beer.
- 1 carton (200 cigarettes), up to 50 cigars, and 200g of loose tobacco
- Up to \$60 in gifts per recipient. (excluding alcohol and tobacco)
- You can bring a "reasonable amount of perfume.
- There are no restrictions on cameras
- You can bring a "reasonable amount" of film
- You can bring gifts duty free so long as none exceed \$60

You are not allowed to combine your personal exemptions with someone else or transfer them to another person.

Goods brought in for commercial use, or for another person, do not qualify under the personal exemption and are subject to full duties.

#### **Duties on Americans Returning to the U.S.**

The amount of your personal exemption is dependant on how long you were out of the country.

- Less than 48 hours \$200.00 worth of goods, per person, is tax and duty free. This can
  include 150 ml (5 oz) of alcohol and 10 cigars (non Cuban). U.S. citizens may buy these
  amounts daily.
- Over 48 hours \$800 worth of goods, per person are tax and duty free. Purchases may include 1 liter of liquor, 200 cigarettes (1 carton), and 100 cigars. U.S. citizens may buy these amounts once a month. Family members may combine their tax and duty allowances.

Duties will apply when you exceed these allowances. Typical charges are \$2.00 – \$3.00 per bottle of liquor, \$1.30 per case of beer and \$3.90 per carton of cigarettes. U.S. duty rates on purchases exceeding 1 liter of booze are assessed according to alcohol content. Children are entitled to a personal exemption as long as the goods they are declaring are for the child's use.

#### Crimes That Will Make You Inadmissible to Canada

we recommend contacting the border prior to crossing and asking them specifically if your crimes would allow you to enter Canada as there is no definitive list.

An offense of driving under the influence will typically not cause problems for Canadians entering the United States. However.....

The biggest surprise for most Americans is that they are *very* likely to be turned away at the Canadian border if they have *any* type of alcohol related offense.

- It does not matter if you are arriving as a passenger in another person's car.
- It does not matter if you have no intention of driving in Canada at all. For example, 4 to 5 passengers a week who take the ferry to Victoria Canada for a one-day walking sightseeing trip are turned back for DUI / DWI offenses even though they do not have a car with them.
- It does not matter if your offense was classified as a misdemeanor or a felony.
- It does not matter if you are a fan, guest, official, or anyone else entering Canada for special events. Former U.S. President G.W. Bush had to get a special waiver to enter Canada because of his 1976 drunken-driving offense in Maine.

We have a <u>short video</u> you can view which provides an overview of your options to enter Canada with a criminal record.

#### Several Things You Shouldn't Do

Don't lie. If you are caught misrepresenting your record your chances of ever getting across the border again will drop significantly. Canadian officers can ban you on the spot for an extended time and perhaps for life.

Secondly, do not attempt entry at a different border crossing on the same day thinking you have a fresh chance with a new officer. Denied admissions are updated *immediately* in a centralized database and will be visible at all ports of entry. If you look like you are trying to evade the system you will further jeopardize your ability to enter the country for the rest of your life.

#### TTC Routes:

#### 29 Dufferin Bus

Take the Bloor subway to Dufferin Station, board the #29 bus south to Exhibition Place. Please note that the #29 Dufferin stops at Dufferin Gate Loop and does not enter the grounds from mid-June until after the CNE.

#### 121A/C Fort York-Esplanade

This bus route originates at Front St East at Parliament St. and will drop passengers off at Princes' Gates loop.

Please note that during the summer, the 121A (Exhibition Place-Distillery) branch operates all day, every day outside the summer months. The 121C (Exhibition-Cherry Beach) is a seasonal route that operates from mid-May to mid-October.
